XI European Regional Congress on Labour and Social Security Law

The XI European Regional Congress was held from 17 to 19 September 2014 in the city of Dublin (Ireland). Executive Committee of the ISLSSL

The XI European Regional Congress also included a meeting of the **ISLSSL Executive Committee**, which was attended by four of the Society's Honorary Presidents and its Officers, as well as representatives of 34 national associations, of which 29 were entitled to vote. During the meeting (the minutes of which are now available), a **new President was elected, the honour going to Professor Tiziano Treu, an eminent Italian legal scholar whose candidacy was proposed by our Italian chapter.**

The Society also has some new members: the Portuguese Association of Labour and Social Security Law, the Moroccan Association of Labour Law, and the Brazilian Academy of Labour Law (which replaces the previous Brazilian member). The Bulgarian Society of Labour and Social Security Law has also rejoined the Society as an active member.

The Executive Committee accepted an offer from the Panamanian Academy of Labour Law to organize the X American Regional Congress in 2016, as well as an offer made by Prof. Takashi Araki, representing the Asian region, to host the IX Asian Regional Congress (2016) in India. The Italian Association presented itself as a candidate to host the next World Labour Law Congress (2018) and put forward some ideas concerning its organization.

Asian Conference on Globalization and Labour Administration: Cross-border Mobility, Social Security and Regional Integration

The Asian Conference on Globalization and Labour Administration: Cross-border Mobility, Social Security and Regional Integration was held from 19 to 21 November 2014 in Manila (Philippines). The event, the first to be held in the region under ISLSSL auspices since the VIII Asian Regional Congress in Taipei (October-November 2005), was organized by the Philippine branch of the ISLSSL, the University of the Philippines and the International Labour Organization's ASEAN Triangle Project. Seminar on International and Comparative Labour Law, Ca' Foscari University, Venice

Following the success of the first Seminar on International and Comparative Labour Law held at Ca' Foscari University, Venice, under the leadership of Prof. Adalberto Perulli (see <http://islssl.org/seminar-on-international-and-comparative-labourlaw-venice-italy-update/>), a second edition, entitled “Enterprise Transformation and Social Rights”, is scheduled for 30 June to 9 July this year, featuring a programme and speakers of the highest quality (<http://islssl.org/2ndinternational-seminar-on-international-and-comparative-labour-law/>). Graduate Seminar on International and Comparative Law, Margarita Island (Venezuela)

Labour Law Yearbook

As soon as we became responsible for administering the ISLSSL, we proposed to the International Association of Labour Law Journals (IALLJ) that we should together develop a yearbook containing important articles published in IALLJ-member journals. We were convinced that a publications of this kind would make a significant contribution to legal knowledge in our field and enable a wider public to access these specialized journals.

Today we are very pleased to announce that the first volume of this yearbook is almost ready and will be published in the near future. For the sake of brevity, we are attaching the contents page of the yearbook, the preface written by the IALLJ President, Prof. Steven Willborn, and the back cover of this first edition.

We also take this opportunity to congratulate Steven Willborn, Prof. Alan Neal, of the University of Warwick (UK), who has written an excellent explanatory introduction, and all those who have contributed to this work. Without their efforts and the good will of the IALLJ-member journals, this project – an eloquent expression of what can be achieved through inter-institutional collaboration - would not have been possible.

Young Legal Scholars' Section

The Young Legal Scholars' Section of the ISLSSL continues to run a wide range of activities.

The newly formed Latin American group, which held its first meeting at the 2013 American Regional Congress in Guayaquil, has produced 11 national reports of exceptional quality, most of which can be read at <http://islssl.org/category/young-legal-scholars-section/>. This very interesting material has been put together in a work co-edited by the Universidad Autónoma de Mexico (UNAM) and the ISLSSL, entitled “Panorama del Derecho del Trabajo y de la Seguridad Social en América Latina” (“Labour and Social Security Law: the Latin American Panorama”), under the leadership of Juan Pablo Mugnolo and Oscar Zavala Gamboa. Patricia Kurczyn, President of the Mexican Labour Law and Social Security Society has written an introduction entitled “Derecho comparado del trabajo; deliberaciones latinoamericanas” (“Comparative Labour Law: A Latin American Perspective”), and there is a forward by the President of the ISLSSL concerning the Young Scholars' Section.

Meanwhile, the newly established European group held its first formal meeting in Dublin, during the IX European Regional Congress. The topic of the meeting was the impact of the economic crisis on recent developments in national labour law systems in European countries (covering various aspects of individual labour law, trade union and collective bargaining regimes and social security law). The 12 national reports presented at the meeting can be viewed on our website at <http://islssl.org/category/young-legal-scholarssection/>. The debates were of the highest quality, to the great satisfaction of all participants, who expressed an interest in further activities. As a result, the Spanish Association of Labour and Social Security Law, led by its President, Jesús Cruz Villalón of the University of Seville, professors Yolanda Maneiro Vázquez and José María Miranda

Boto of the University of Santiago de Compostela and Stefano Bellomo, the ISLSSL Treasurer, are organizing a meeting which will take place, under ISLSSL auspices, on 4 and 5 June 2015 at the Law Faculty of the University of Santiago de Compostela. The purpose will be to study the case law of supranational courts from a comparative perspective. The organizers also intend that the meeting should be an opportunity to share ideas on the possible establishment of a European regional sub-section of the Young Scholars' Section of the ISLSSL, which is set to become a single entity at the World Congress in Cape Town. The meeting programme is hereby attached.

Finally, a further session of the Young Scholars' Section is planned as part of the forthcoming World Congress, to be held in September in Cape Town. It is intended that a single global entity – the ISLSSL Young Legal Scholars' Section – be constituted by merging the Latin American and European “embryos”, and incorporating the many national sections and representations set up within the national societies affiliated to the ISLSSL.

XXI World Congress of Labour and Social Security Law, Cape Town, September 2015

During the meeting of the Executive Committee held in Dublin on 17 September last year, Prof. Darcy Du Toit, representing the South African organizing committee, shared a wealth of information on the XXI World Congress, due to take place in Cape Town, South Africa, in September 2015. The Congress agenda was given final approval and is available, with further information, at <http://www.labourlawcongress2015.co.za>.

The organizing committee have just sent us a progress report, available at <http://islssl.org/newsflash-capetownworld-congress/>. They have also informed us that a number of sponsors have given their backing to the event, many people are already registering to take part, and a substantial number of papers and abstracts have been received. The organizing committee also informs us that, at a special session on Wednesday, 16 September, a panel of international experts, academics and practitioners, chaired by Professor Manfred Weiss, Emeritus professor at the Law Faculty of the Johann Wolfgang Goethe University in Frankfurt, will discuss “How to cope with fragmentation and segmentation of the workforce”.

Preface

The *International Association of Labour Law Journals* is a consortium of 25 journals from around the world dedicated to publishing the best research and thought in labour and employment law and policy. Its member journals are listed on the next pages and more information about them can be found on the Association's website at <http://www.labourlawjournals.com>. This work is a collaborative project of the Association and the International Society of Labour and Social Security Law (www.islssl.org), with whom we have worked closely on this and other projects.

The Association began life as the "International Club of Labour Law Journals", which owed much to the late Marco Biagi (1950-2002) for its inception and early co-ordination. Having attended, together with Alan Neal, an exploratory meeting of industrial relations journal editors, convened during the 7th World Congress of the *Industrial Relations Research Association* in Hamburg in September 1986, Marco became enthused with the notion of establishing an equivalent body dedicated specifically to comparative labour law journals. This led to the editors of a number of labour law journals being invited to a meeting arranged by Marco in Bologna the following year, hosted by the journal *Lavoro e Diritto*.

That initiative was followed, at the beginning of November 1988, by a major conference in Paris, generously organised by the French Ministry of Labour, under the auspices of its journal, *Travail et Emploi*. A similarly large-scale gathering was organised in the following year by the Spanish Ministry of Labour, in conjunction with the journal *Relaciones Laborales*.

In light of those experiences, a view was formed that the emerging organisation might operate more effectively as a gathering of journal editors if it were to hold more compact meetings, with a part of the available time being set aside for discussion of editorial, production, and related matters of common interest between the participant journal members. A return to the original Bologna format was therefore agreed, and, in November 1990, a meeting of a dozen journal editors took place in Leicester, at the end of an international colloquium organised by

the *International Journal of Comparative Labour Law and Industrial Relations*.

That smaller-scale format served well, and formed the basis for annual meetings thereafter, with Marco taking on the mantle of president for what was then known as the "International Club". Following Marco's assassination in March 2002, his successors to the presidency, Jeffrey Sack (Canada) and Guido Balandi (Italy), devoted their efforts to refreshing and enlarging the organisation and reconstituting it as an Association. Today, it has become a unique world-wide collaboration between the leading journals in the field.

In 2012, Adrián Goldin, the President of the International Society of Labour and Social Security Law, suggested that the Association and the International Society collaborate to produce an annual volume of important research in labour and employment law, drawn from the pages of the Association's member journals. At its annual meeting in Bordeaux in 2013, the Association decided to pursue that suggestion. This collection of scholarship is the first in the series.

While all of the articles in this volume except for the Introduction by Alan Neal have already been published elsewhere, the Association presents them again to expose them to new and broader audiences. It is also the hope that publication of this volume as a separate venture will draw heightened attention to the journals participating in this effort. If, as a reader, you find that the articles in this volume are interesting and insightful, we would encourage you to make reference to the journals from which they have been drawn. The articles included here constitute only a taste of the wide range of important research being published in the journals represented in the volume, and by all of the Association's member journals. If you are impressed by the articles, as we expect you will be, you might even think of subscribing to some of the journals!

Having said this, it needs to be borne in mind that the *International Association of Labour Law Journals* is a large and diverse group. The views expressed in all the contributions which make up the volume, including the Introduction, are those of their authors, and the Association adopts no position in relation to any of the views offered by those authors.

I have been involved in this effort as an editor and the main cheerleader. I want to thank all the editors from the participating journals who have made this possible through their prompt and willing co-operation. We have also been very pleased to collaborate closely with

the International Society for Labour and Social Security Law on this project, and we have especially appreciated the support and encouragement of the Society's President and its Secretary-General, Adrián Goldin and Giuseppe Casale. Finally, this project would not have been possible without careful and patient editorial work by Boris Bohuslawsky, Kerry O'Neill, and Bambi King. Thank you so much.

The Philosophy

This meeting of the European YS Embryo is the continuation of the session held in Dublin in September 2014. There, all the Young Scholars who attended it confirmed their gladness and satisfaction and their will to being involved in the future activities related to the European embryo and of the future ISLSSL Young Scholars' Section. The same availability and willingness have been expressed by many scholars who attended and appreciated the contents of the meeting.

Implementing these intentions, the meeting in Santiago de Compostela will have two aims.

First of all, a scientific objective, the exam of the jurisprudence of supra-national courts, a meeting point for all the countries of the European area (Austria, Belgium, Belarus, Bosnia Herzegovina, Bulgaria, Croatia, Czech Republic, Denmark, Finland, France, Germany, Greece, Hungary, Ireland, Israel, Italy, Lithuania, Luxembourg, Netherlands, Norway, Poland, Portugal, Romania, Russian Federation, Slovenia, Spain, Sweden, Turkey and United Kingdom). Thus, a common field for debate is easily found, as the same decisions from these Courts can have very different impacts on each country. The mechanics of the meeting are based on debate, following the successful model already implemented twice by the Spanish Young Scholars' Section. Short dual presentation of 10 selected rulings will be followed by open, wide debate, free of the formalities of a Major Congress, and with a good deal of time to talk without restriction.

The second aim is an organizational aim. The World Congress in Cape Town, September 2015, will be the birthplace of the ISLSSL Young Scholars' Section, joining young scholars from the entire World. The meeting in Santiago will be the occasion for brainstorming and sharing ideas for a possible European Regional subsection and further collaborations in the future.

Attendance Rules

Participation will be possible in this Meeting under two roles: discussant and attendant.

The discussants, in couples, will expose the judgments to open the debate. Each National Association affiliated to the International Society of Labour and Social Security Law will propose one or two discussants, up to 20 participants; the nomination will be communicated to both stefanobellomo@mmba.it and josemaria.miranda@usc.es before the 10th March 2015. If this number is not reached, an open call for discussants will be made, and a number of grants will be distributed, according to a merit-based selection process managed by the ISLSSL, to fill the number of 20 discussants, coming from the indicated countries from the European area. In any case, no more than one discussant per country will be selected according to this second procedure. The choice of the rulings will be made though the YS website

(<http://www.euryoungscholars.unimi.it/>) under the supervision of the ISLSSL, during the month of March.

As attendants, each National Association can appoint a wider number of representatives according to its own rules – no grant will be given to them by the ISLSSL. Furthermore, the attendance to the academic session and to the debate is open to each Young Scholar who is interested in studying the issues that will be examined and debated in the Seminar. Attendants are invited to engage in the debate following the exposition by the discussants. Of course, attendants from extra-European countries are welcomed to participate in the meeting.

Anyway, the organizers wish that the Seminar could represent an occasion for the National associations to establish and promote the activity of the respective national Young Scholars' Sections.

The working language will be English and the dress code is casual.

Registration fees

120 Euros. The fees include academic materials, accommodation for two nights, one lunch, two dinners and social events.

The ISLSSL will give a grant of 50 Euros to each of the discussants, up to two per country, with a top expenditure of 1000 Euros.

OBJETIVO GENERAL:

El Seminario de Post Grado Internacional y Comparado sobre Derecho del Trabajo se ha venido realizando en la Isla de Margarita, Venezuela, por iniciativa de la Sociedad Internacional de Derecho del Trabajo y de la Seguridad Social que propuso a Universitas Fundación la realización de un ciclo de estudios avanzados dedicados a jóvenes especialistas en estas disciplinas. Su primera edición se celebró en el año 2011. Este seminario contará con la directriz de distintos profesores especialistas en la materia de diversas nacionalidades como lo son: Humberto VILLASMIL PRIETO (OIT), César CARBALLO MENA (Venezuela), Jorge ROSENBAUM (Uruguay), José Luis UGARTE (Chile), Oscar HERNÁNDEZ ALVAREZ (Venezuela) y Rolando MURGAS TORRAZZA (Panamá). Su contenido ha sido diseñado con la premisa de atender todas y cada una de las necesidades de formación en esta actualización específica.
